Ballet:

Pre-Ballet and Pre-Ballet/Pre-Tap combo classes:

Light Blue leotard, Light Pink leotard, or Black leotard, matching colored skirt (optional)

Pink ballet shoes and pink tights

Hair in ponytail or bun, hair must be off the face

Ballet 1-4 and Pointe:

Black leotard

Black ballet skirt (optional)

Pink ballet shoes (leather or canvas) and pink tights

Hair in a neat bun

Contemporary:

Black leotard with black leggings, tights, or shorts Ballet shoes, half contemporary shoes, or barefoot

Hip-Hop:

Athletic Top or T-shirt, crop tops OK but belly buttons <u>must be covered</u>
Shorts, leggings, or sweatpants. <u>NO JEANS</u>
Sneakers (separate pair for just the studio, <u>no shoes worn outside of the studio are to be worn in the classroom)</u>

Donna's Studio of Dance Policies

- 1. Notify the director at the time of registration if the dancer will not be participating in the annual recital.
- 2. Students cannot be enrolled after November 30th.
- 3. Our season begins Tuesday, September 5th 2023, it ends May 17th, 2024.
- 4. Accept an evaluation for placement of the dancer, if needed.
- 5. Any concerns or complaints need to be brought to the attention of the Director.
- Children/Dancers and Parents/Guardians are to follow the rules, including in the lobby area.
- 7. Follow the Rules & Regulations, Understand the Release of Liability, Dress Code, Attendance Policy, Payment Obligations, Recital Policy, and Costume Policy/Fees.

Rules and Regulations

- 1. Respect teachers, assistants, fellow students and fellow parents/guardians.
- 2. Teachers must be present before students enter the classroom.
- 3. Only those attending the class are to be allowed in the classroom.
- 4. No running in the lobby or classroom
- 5. Keep all personal belongings in the lobby area, no toys are allowed in the classroom.
- Listen to teachers and assistants, no talking while they are instructing.
- 7. Wear the appropriate dress code for the class- attire must be clean.
- 8. No outside shoes in the classroom- have a separate pair of sneakers for Hip-Hop.
- 9. Hair must be away from face at all times. Hair in a neat bun for ballet classes.
- 10. Arrive to class no earlier than 15 minutes, be ready for class.
- 11. If a student is not picked up within 5 minutes after class; a late pickup fee will be charged \$1/per minute after class
- 12. Do not distract your student through the window, you will be asked to change seats.
- 13. No loud music or movies in the lobby area, please use headphones.
- 14. Speak quietly in the lobby area while waiting on your students or for your class to start.
- 15. No bad language in the lobby or the classroom.
- 16. Do not rearrange the chairs, furniture, or cushions.
- 17. Use the restroom before class begins.
- 18. Only water is welcome in the classroom. No gum chewing or food is allowed in the classroom.
- 19. No hanging or sitting on the ballet barres.
- 20. Bullying or harassing will not be tolerated.
- 21. Practice good hygiene
- 22. Have fun!

Attendance Policy

- 1. Attend dance classes on a regular basis.
- 2. Notify the Director if the dancer will be absent.
- 3. Notify the Director if the dancer is changing classes or discontinuing dance lessons.
- 4. Attend any and all dress rehearsals.
- 5. Attend any and all designated performances and recitals.
- Students will be dropped from class after three consecutive weeks of non-attendance if the Director is not notified of the absences. Returning to classes will include a \$20.00 re-registration fee.

Payment Obligations

- 1. Payment is due the first week of each month to Donna's Studio of Dance.
- 2. Three or more weeks per month is considered a full month of tuition.
- 3. Monthly tuition fees are to be paid for the month even for weekly non-attendance.
- 4. Accepted forms of payment are checks written to Donna's Studio of Dance, money orders, cash, or online payment.
- 5. Checks, money orders, and cash should be placed in an envelope with the child's first and last name on the front of the envelope, and dropped in the lobby tuition box.
- 6. All payment obligations for the season must be paid in full by dress rehearsal to be able to participate in the recital.
- 7. Annual Registration Fee per dance student is \$20.00 at the time of registration.
- 8. Each 1/2 hour weekly class is \$45.00 per month
- 9. Each 45 minute weekly class is \$55.00 per month.
- 10. Each 1 hour weekly class is \$70.00 per month.
- 11. There is a 10% discount when you pay for the year in total, this does not include Costume fees.
- 12. If a student is not picked up within 5 minutes after class; a late pickup fee will be charged \$1/per minute after class.

Policy for Dropping Classes

- 1. Notify the director if you or your child is dropping 1 or more classes.
- 2. Students can drop classes without repercussions up to November 30th.
- 3. Students can not be re enrolled in a class they dropped after November 30th until the following season.

Costume Policy and Fees

- 1. Costume Fee is \$100.00 per class. Payment is accepted until November 30th.
- 2. Costume Fee is non-refundable after November 30th.
- 3. All female students are required to purchase a camisole leotard to be worn under each costume at recital if the student is in more than one class. Camisole leotard fee is \$20.00 to be paid with the Costume fee no later than November 30th.

Recital Policy

- 1. Recital is scheduled in May. The date of recital is dependent on the availability of the high school auditorium venue.
- 2. Notify the Director at time of registration if the dancer will not participate in the recital.
- 3. Attend any and all dress rehearsals.
- 4. Follow all rules set by the Director for backstage, onstage, and audience etiquette.
- 5. Students are not to leave the property on the day of Recital if two shows are being held.
- 6. Attend any and all designated recital times.
- 7. Arrive to dress rehearsal and recital at call time, in costume with hair and makeup done.
- 8. Any parent signed up to work backstage will receive one (1) free tickets to the performance you are not volunteering for.
- 9. Any parent electing to sit with their child backstage will not be allowed to watch the show without a ticket.
- 10. Recital Tickets will be sold during picture week (time and dates TBD.)

 2 (two) tickets will be sold to each family, regardless of the amount of students enrolled.

 On the night of Dress Rehearsal, more tickets may be purchased on a first come-first served basis. Any remaining tickets will be sold at the door the Day(s) of the Recital.
